4. End User Certifications and Commitments

End User hereby certifies, confirms and agrees that:

- a) It is purchasing/receiving Juniper goods, services and/or technology solely for its own use in its own operations and not for resale or other disposition to anyone else.
- b) All responses furnished items 1 through 3, above, are current, complete and accurate. If at any time any of the information provided in this EUC should become no longer current, accurate and complete, End User shall promptly complete, sign and submit an updated version of this EUC to Juniper Networks either online or via email addressed to tradecompliance@juniper.net.
- c) It shall not directly or indirectly transfer, loan or otherwise give access to any such Juniper goods, services or technology to any party or location under economic sanction or re-export prohibition imposed by the Government of the United States, the UN Security Council, by the European Union or any member nation thereof, Singapore, Hong Kong, the United Kingdom or the government of any country in which End User installs or uses any such items. Such prohibited locations include, among others, Cuba, North Korea, Iran, Syria, Sudan and the regions of Crimea and Sevastopol. Such sanctioned parties include, without limitation, those identified on the Consolidated List posted at <http://apps.export.gov/csl-search#/csl-search>.
- d) End User shall neither use nor allow anyone else to use any Juniper goods, services or technology in support of any of the following:
- the design, development, fabrication or testing of nuclear weapons or nuclear explosives
 - the design, construction, fabrication, or operation of facilities for the chemical processing of irradiated special nuclear or source material, for the production of heavy water, for the separation of isotopes of special nuclear material or for the fabrication of nuclear reactor fuel containing plutonium
 - the design, development, production of or use of rocket or missile systems, space launch vehicles, sounding rockets, or unmanned air vehicle systems (including cruise missile systems, target drones and reconnaissance drones)
 - the design, development, production, stockpiling, or use of chemical or biological weapons, or precursors
- e) It shall not cause or allow any Juniper goods, services or technology to be re-exported or sold to any third party who is known or suspected to be involved in relation to nuclear, biological or chemical weapons, or missiles capable of delivering those weapons.
- f) It shall not make use of Juniper goods or services in whole or in part, in connection with any activity in violation of human rights, of democratic principles or of the freedom of speech as defined in the Charter of Fundamental Rights of the EU where use is made of interception techniques and digital data transfer equipment for monitoring mobile phones or for reading text messages or where use is made of targeted surveillance of internet use (e.g., by means of monitoring centers and lawful interception gateways).
- g) It shall not re-export or sell any Juniper goods to any third party except in accordance with all applicable export control laws and regulations.
